4. Bidder should demonstrate the working of the equipment at the time of installation and get approved by the committee.
5. The supplier should quote the rates as per specification given in Annexure. -1
6. During the warranty period, the firm furnishing quotations shall attend all the hardware problems on site and shall replace the defective part at no extra cost to ensure uninterrupted office functioning. Failure of it will charge penalty towards the firm and the authority will fix the amount at moment of time.

**Terms of Delivery**

1. The firms furnishing the quotation should be able to supply the stated quantity within 30 days.
2. Cable and cabling with 20 mm conduits, accessories and labour will be done by the consumer.
3. The equipment shall be free from any defect due to the defective materials. Damaged/ missing parts of the equipments shall have to be accepted back by the supplier.


