We do hereby undertake to pay to the Secretary, KSELB an amount not exceeding ₹ against any loss, or damage caused to, or against amount found due at any time from the said Contractor on account of his failure to fulfill the condition of Licence by him with the KSELB.

We, do hereby undertake to pay to the KSELB the amount due and payable under this guarantee without any demur merely on a demand from the KSELB stating that the amount claimed is due by way of loss or damage caused to or would be caused to or suffered by the KSELB by reason of any breach by the said condition or any of the terms and conditions for the grant of Contractor Licence Grade 'A'. We, further agree with the KSELB that the KSELB shall have the fullest liberty without our consent and without effecting in any manner our obligation hereunder to vary any of the terms and conditions of the said conditions or to extend time or to postpone for any time or from time to time any of the powers exercisable by the KSELB against the said Contractors or to cancel or renew the registrations and to forbear or enforce any of the terms and conditions relating to the said conditions and we shall not be relieved from our liability by reason or any such variations of extension of the contractors being granted to the said Contractors or of any cancellation or renewal of the registration of for any forbearance act or omission on the part of the KSELB or any indulgence by the KSELB to the said contract/s by any such matter or thing whatsoever which under the law relating to the sureties would but for this provision have the effect of so relieving us.
